We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 6th September 2023.

Your request was as follows:

I am submitting this request under the Freedom of Information Act 2000. I am requesting information from the following financial years: 2018/19; 2019/20; 2020/21; 2021/22; 2022/23; and 2023/24 to the present day.

Please disclose the following:

1. How many employment tribunal (ET1) claims have been made against the organisation since 2018/19;

If possible, please break this down by type (e.g., public interest disclosure, unfair dismissal, discrimination). If this brea kdown takes too long to respond to the FOI then please omit it.

- I can confirm that the Walton Centre NHS Foundation Trust have had 3 employment tribunal claims made against the Trust between 2018 and 2023. I can confirm that this has been provided as a total figure as breaking the data down further or disclosing the type of case, may lead to the staff involved being identified and is therefore exempt under Section 40 (2) of the FOIA 2000.
