I'd like this information for each of the last five years, with June 30 as year-end. If this is not possible then please use the year-end used internally by the organisation.

If you are unable to provide numbers for both the annual allowance tax charges and the lifetime allowance tax charges, please prioritise data for the annual allowance tax charges.

I can confirm that the Walton Centre NHS Foundation Trust have had 4 doctors return to the Trust after retiring over the last five years. The breakdown is below:-2 x 2018 1 x 2020 1 x 2022
