## Re: Freedom of Information Request FOI 5929

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 13th September 2023.

Your request was as follows:

I am writing to request information under the Freedom of Information Act regarding pest control measures at your NHS Trust's hospital sites over the last five years.

Specifically, I would like to obtain the following data:

> The total number of times exterminators or pest control services were called at each hospital between 2018 and 2023 to date.

The Walton Centre NHS Foundation Trust has had 51 call outs for pest control between 2018 and 2023 to date.

> A detailed breakdown of the reasons or specific pest issues that led to the calls for exterminators during this period and the actions exterminators and pest control took to remedy this.

We do not have detailed breakdowns but the sub categories for call outs are as follows:

- Guano removal
- ■Supply of glue boards
- •□Netting replacement/repair
- •□Bird spiking replacement/repair
- ■Spray treatment
- •□Clean and sanitisation
- ■Wasp treatment
- ■Remove nesting material
- □Pest removal
- > The total cost incurred, broken down by hospital, for pest control services, including the costs of removing pests, shooting pigeons, and other related expenses in the timeframe.

The total cost for pest control services for the WCFT is £36,993.


