**Re: Freedom of Information Request FOI 6283**

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 18th April 2024.

Your request was as follows:

I am carrying out some research for a report, trying to ascertain preparedness for carbon zero in the public sector. I am particularly interested in public sector organisation's understanding of current energy usage.

I would like to know:

- a) The total number of electric, gas, fuel & water meters the organisation has (billing meters and sub-meters).
- b) The number of those meters that are manually read & recorded.
- c) The number of those meters that are AMR (Automated Meter Reading) meters.
- d) Across how many sites the meters distributed.

Please note that I am only interested in the organisation's buildings - not domestic buildings associated with the organisation.

- a) - Electric -3, Gas - 2, Heat - 2, Water - 1
- b) 6 Manual
- c) 2 Automated
- d) 2 sites
