Re: Freedom of Information Request FOI 6334

We are writing in response to your request submitted under the Freedom of Information Act, received in this office on 28th May 2024.

Your request was as follows:

Does the trust work with translation services that translate healthcare information communications, e.g. leaflets, letters, posters etc?

Yes, the Walton Centre NHS Foundation Trust use DA Languages to provide translation and interpretation services.

How many healthcare information leaflets/communications did the trust produce and print in FYE 2024?

The WCFT do not have this information as these are produced as part of a bulk corporate printing bundle.

How many of these were translated in multiple languages?

All patient information leaflets are available in multiple languages.

Which languages does the trust normally translate healthcare information communications into?

Most leaflets are available in Arabic, Chinese, Farsi, French, Polish, Punjabi, Somali, Urdu and Welsh.

How are healthcare information communications delivered to patients that are visually impaired?

Depends on individual needs (can organise to have in large font, braille as required)

What did the trust spend on translation services for healthcare communications in FYE 2024?

The contract value for DA Languages for 23/24 was £94,058.71.

What did the trust spend on printing of healthcare communications in FYE 2024?

This cost is included within the DA Languages contract.


